Festival Terms and Conditions:

- 1.) El "Día De San Juan" Festival Scholarship Fund Raising Event holds the exclusive rights to sell **ALL** beverages including but not limited to alcoholic and ethnic drinks. Vendors found selling beverages will be shut down and vendor booth payment and fees will be forfeited.
- 2.) Vendor agrees to sell only those items for sale as indicated on vendor application and approved by the Western Region Puerto Rican Council (WRPRC). Merchandise vendors may sell **only** merchandise items. Vendors found in violation will be shut down and/or vendor booth cleaning fee will not be refunded.
- 3.) The WRPRC shall have sole discretion to vendor booth/space placement.
- 4.) Doors open at 7:00 a.m. - to 10:00 a.m. for vendor set up. Vendors may not be granted access to the festival grounds if he/she arrives after 10:00 a.m. Any fees paid are non-refundable and shall be forfeited by vendor if he/she arrives later than 10:00 a.m.
- 5.) Vendor is permitted to bring a maximum of three **(3)** assistants with him/her at no cost. Vendors that exceed the limit of three **(3)** assistants are subject to pay the advanced ticket price of \$20.00 for each additional assistants or volunteers. For more than three **(3)** assistants, please present your paid ticket to the gate attendee or you may purchase your ticket at time of check in.
- 6.) The Council and/or park shall not be responsible for vendor's failure to bring the appropriate supplies to conduct business.
- 7.) Damage to History Park grounds is prohibited. Vendors must maintain canopy area clean and free of food, debris, etc., at all times. *Rented equipment such as canopy, tables and chairs must be accounted for. Any damage sustained to the rented equipment while in your possession is your responsibility and will be deducted from your deposit and/or vendor will be subject to a fine and will not be invited to future festivals if found in violation.*
- 8.) A complete grounds inspection of your immediate area will be conducted by the History Park staff immediately following the festival. Your deposit will be refunded with a "pass" review from the History Park staff and if vendor has met all criteria as per #7.
- 9.) Tear down **cannot** begin before 6:00pm and **must** be completed by 8:30pm.

By submitting this vendor application, I/We hereby waive, release and discharge all claims for damages for personal injury, death or property damage which may occur because of participation in the 39th annual El "Día De San Juan" Festival – Scholarship Fundraising Event. I/We agree for myself, my heirs, administrators, executors and assigns, that I/We shall indemnify, make no claim and hold harmless the Western Region Puerto Rican Council, its committee, agents, and its affiliated member club organizations: Puerto Rican Civic Club (PRCC) of San José, Club Puertorriqueño de San Francisco (CPSF), Puerto Rican Union of Mutual Aid (PRUMA), Puerto Rican Organization United for Development (PROUD), any individual Council Member, Club Member, Delegate, Alternate, Member at large, and any person or organization affiliated with the Festival, the Park, City of San Jose, their respective elected and appointed officers, official agents and employees and their staff from any and all claims, demands, actions or suits arising out of or in connection with my participation in this event.
