Festival Terms and Conditions:

- 1.) El Día De San Juan Festival Scholarship Fund Raising Event holds the exclusive rights to sell **ALL** beverages including but not limited to alcoholic and ethnic drinks. Vendors are **not** permitted to sell any drinks of any kind at El Día De San Juan Festival 2010 Scholarship Fund Raising Event.
- 2.) The WRPRC shall have sole discretion to vendor booth/space placement.
- 3.) Doors open at 6:30 a.m. - to 10:00 a.m. for vendor set up. Vendors will not be granted access to the festival grounds if he/she arrives after 10:00 a.m. The fees paid are non-refundable and shall be forfeited by vendor if he/she arrives later than 10:00 a.m.
- 4.) Vendor is permitted to bring a maximum of three **(3)** assistants with him/her at no cost. Vendors that exceed the limit of three **(3)** assistants are subject to pay the advanced ticket price of \$20.00 for each additional assistant/volunteer and/or representative. Vendor and all assistants must show valid ID during check in. For more than three **(3)** assistants, please present your paid ticket to the gate attendee or you may purchase your ticket at time of check in.
- 5.) The vendor agrees to sell only those items for sale as indicated on vendor application and approved by the Western Region Puerto Rican Council (WRPRC). Merchandise vendors may sell only merchandise items.
- 6.) Vendor must show proof of license to conduct business in the State of California.
- 7.) The Council and/or park shall not be responsible for vendor's failure to bring the appropriate supplies to conduct business.
- 8.) Vendor must maintain booth/canopy area clean and free of food, debris, etc., at all times. Damage to History Park grounds is prohibited. Vendor applications will not be not be honored for future festivals if found in violation.
- 9.) Cleaning deposit will be refunded following a complete grounds inspection of your immediate area after the festival.
- 10.) You are responsible for any damage sustained to any rented equipment. You are responsible for stolen rental equipment.
- 11.) Tear down **cannot** begin before 6:00pm and **must** be completed by 8:30pm.

By submitting this vendor application, I/We hereby waive, release and discharge any and all claims for damages for personal injury, death or property damage which may occur as a result of participation in the 32nd annual El Día De San Juan Festival. I/We agree for myself, my heirs, administrators, executors and assigns, that I/We shall indemnify, make no claim and hold harmless the Western Region Puerto Rican Council, its committee, agents, and its affiliated member club organizations: Centro Borinqueño de Mountain View (CBMV), Puerto Rican Civic Club (PRCC) of San José, Club Puertorriqueño de San Francisco (CPSF), Puerto Rican Union of Mutual Aid (PRUMA), Puerto Rican Organization United for Development (PROUD), any individual Council Member, Club Member, Delegate, Alternate, Member at large, and any person or organization affiliated with the Festival, the Park, City of San Jose, their respective elected and appointed officers, official agents and employees and their staff from any and all claims, demands, actions or suits arising out of or in connection with my participation in this event.
